services under the Individuals with Disabilities Education Act (IDEA). Such services are commonly referred to as extended school year (ESY) services. ESY can be an extension of your student's normal day.

The best time to discuss the ESY program is at your child's annual IEP review.

1. Obtain a copy of any ESY determination guidelines.
2. Don't wait until late in the normal school year to discuss your child's potential need for ESY services during summer break.
3. List all factors you think should be taken into consideration.

Things To Consider: Summer Camp! Applications For Financial Support Are Available.

The Children's System of Care provides eligible children and young adults financial support toward summer camp tuition. Financial support is based on available resources in a given fiscal year. The amount of financial support available per individual is capped and may vary year-to-year and by how many families apply.

Completed applications for both Financial Support toward Summer Camp Tuition and One-to-One Aide Services for Summer Camp must be postmarked or received by PerformCare no later than **April 30, 2016**. Your application must be complete for it to be considered.
