

# Timeline for 2014 Graduates to Access Services/Supports after Graduation



## 2013 - What should individuals/families do now?

### **DDD eligibility**

- ❖ If you have not already been deemed eligible for DDD, contact your DDD Community Services Office or start the application process through the DDD website at <http://www.nj.gov/humanservices/ddd/services/apply/application.html>.

### **Medicaid eligibility**

- ❖ DDD's eligibility regulations now require that an individual also be eligible for Medicaid.

### **Plan for life course**

- ❖ It is always easier to identify support needs and access services more quickly when planning has been done prior to exiting the school system. You can use the Person-Centered-Planning Tool (PCPT) available at <http://www.nj.gov/humanservices/ddd/documents/Documents%20for%20Web/PCPT.pdf> to help you with this process.
- ❖ Discuss your 'vision' for life once school is over. Think about where you might work, live, and what supports you may need.

## ***Participate in 'Planning for Adult Life' activities***

- ❖ Training, information, resource materials, and webinars will be offered through DDD's Planning for Adult Life project. This project will be conducted by The Arc of New Jersey and Community Access Unlimited.
- ❖ Activities for students between the ages of 16-21 and their families include, but are not limited to the following: training sessions focusing on topics such as postsecondary education/employment; housing; legal/financial; self-direction; health/behavioral health; and friends/social.

## **Spring 2014 - What should individuals/families do now?**

### ***Complete the Developmental Disabilities Resource Tool (DDRT)***

- ❖ Correspondence including information about accessing and completing the survey has been sent to 2014 graduates. If you have not received the letter, please reach out to your Regional Office to update your contact information.
- ❖ The DDRT can be completed online or via phone call.

### ***Complete Support Coordination Agency Selection Form***

- ❖ Graduates will need Support Coordinators (SCs) from Support Coordination Agencies (SCAs) to assist them in writing their service plan and accessing needed services and supports.
- ❖ Sixty (60) days prior to graduation, complete and submit the SCA Selection Form in order for DDD to assign a SCA based on your indicated preference. If you do not have a preference, indicate that on the SCA Selection Form and a SCA will be auto assigned.
- ❖ The SCA Selection Form and list of currently approved SCAs can be accessed on the DDD website at <http://www.nj.gov/humanservices/ddd/programs/supportsprgm.html>.

### ***Develop DDD's Individualized Service Plan (ISP)***

- ❖ DDD will assign a SCA based upon your Selection Form. The SCA will then assign the Support Coordinator (SC) who will be responsible for writing the Individualized Service Plan (ISP).
- ❖ The Planning Team (individual, SC, family, etc.) will meet to initiate the Person-Centered Planning process and complete the PCPT.
- ❖ The SC develops the ISP with help from the DDRT, PCPT and the Planning Team to identify outcomes, supports, and service providers based upon the assessed level of need.
- ❖ The ISP should be completed and approved within 30 days of assignment to an SCA.

## **Summer 2014 - What should individuals/families do now?**

### ***Access DDD-funded services***

- ❖ SC will make arrangements with the service providers to start services as identified in the approved ISP.
